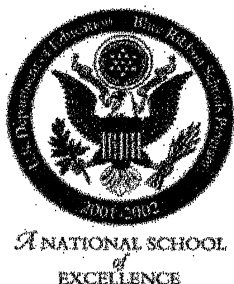

Please review the activities below and mark your calendars with these important dates.

**January 15, 2019** - 8<sup>th</sup> grade Evening Orientation Program, for all our sending school parents will begin at 6:30 p.m. in the Theater. Presentations will include an overview of high school life by administrative staff, in addition to information on the scheduling process. Teachers from the various departments will be available in locations around the building to answer questions afterward. **January 1, 2019** - Scheduling materials including curriculum guides and scheduling contracts will be available for distribution.

**January 15-16, 2019** - Sending schools will be transporting students to North Hunterdon for a half day orientation program on the day that was designated for their school: January 15 (Bethlehem Township, Clinton Public, Union Township, Franklin Township, non-public schools), January 16 (Clinton Township)

**February 1-15, 2019** - North counselors will be available at North for optional appointments with students and their parents. If you would like to meet with a North counselor, please contact the Counseling Office at 713-4130 after winter break. There will be a limited number of slots, so please schedule early if you would like to take advantage of this opportunity to meet to discuss your child's course requests for next year.


**January 15, 2019** - The last day for receipt of scheduling contracts at the North Guidance Office. Submitting course requests after this date may jeopardize the student's chances of obtaining his/her desired courses.

**March, 2019** – Course requests will be posted in Aspen for review. All errors must be reported to Guidance by the end of April.

Enclosed is a copy of our registration form, which must be completed promptly and returned to your school. They will forward them to us. Please note that it is very important to register your son or daughter using his or her full, legal first name. This will be the name that appears on the student's transcript, which is ultimately sent to the college and universities, so it is important to maintain consistency.

We hope this information is helpful to you. We look forward to working with you and to welcoming the class of 2023 to North Hunterdon High School.
